FOR NON PROFIT & COMMUNITY GROUPS**

Participants give WMNF, its employees, agents, and assigns permission to use submitted images of their submitted works for promotional purposes of the WMNF event that they are participating in.

Payments may be made by VISA/MC, check, or money order. Checks/money orders should be payable to WMNF and indicate on the document that the payment is for exhibitor space fee and include event name and date.

Applications and payment are due (postmarked) by March 21, 2011. There is no rain contingency plan. No refunds will be issued by WMNF.

Display Requirements: Each Community Organization Exhibitor is responsible for their display. You must furnish your own table, chairs, table covering and your own set-up for hanging items. If you are bringing additional tables or other display items to augment your set-up, they must fit within your allotted space which is approximately 10' x 10'. Your display must be arranged so that it allows for proper and safe aisle space and does not impede the flow of foot traffic in, past, or around your display area, as determined by WMNF and/or the City of Tampa Fire Marshall. When setting up, please arrange your space so that your clients can transact business with you from within your allotted space.

Assignments are made on a lottery system. You will receive your time and space number prior to the event. Set up times are between 7am and 9am. After unloading, please move your vehicle as soon as possible from the designated unloading area so that other people trying to set up can have access. *To qualify for the discounted off-site parking fee, non-profit/community members must park in the northwest parking lot.*

Water will be available for jug refills near the stage. You will be responsible for keeping your own supply of water on-hand for any pet bowls that you provide. Please plan accordingly.

An accepted application is a commitment on the part of the Applicant to keep their display open during ALL scheduled hours of the Talking Animals Festival. Please do not break down your display before the scheduled closing time of 4:00 pm. After dismantling your display, you are responsible for leaving your exhibit space clean. Please dispose of all your trash in appropriate trash receptacles.
